1. This budget will raise more revenue from property taxes than last year's budget by an amount of \$684,140, which is a 3.81% percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$14,902.

Gentlemen:

For several years Panola County's appraisal values have been decreasing and this year is no exception. In fact the appraisal values for Panola County have decreased by approximately \$1.5 billion dollars since 2008. Although the values for 2013 decreased by what appears to be only a small amount of 4%, it still presents a problem with providing the expected services our citizens expect as well as providing funds for the mandates from the State that are required and that are unfunded by the State. Also the steady decrease in revenue derived from interest income has proven to be problematic.

This proposed budget has very little discretionary expense increases. In Panola County we pride ourselves in not charging our residents for trash disposal yet this expense increases every year. We are also one of only 12 counties in Texas that does not add extra fees on auto registration tags. Some counties are able to gain revenue from sales taxes, but Panola County does not charge any sales taxes. We have taken pride in not charging our employees for their health insurance premiums even though they have increased most years with this year being no exception.

This proposed budget does have a 3% increase in wages for all Panola County employees. Panola County's wages do not compete with our competitors in the private sector nor should we, but we do try to provide an income level that is sufficient for an adequate standard of living for everyone that works for Panola County.

This proposed budget will be more than the effective tax rate, but the elimination of the new discretionary increases by themselves would not be enough to reduce the tax rate to the level of the effective tax rate. I urge the adoption of this proposed budget for FY 2014 as submitted.



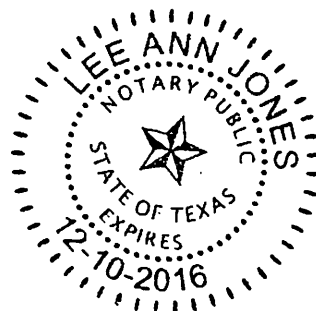
