This budget will raise more total property taxes than last year's budget by \$170,105 or by .96%, and of that amount \$139,662 is tax revenue to be raised from new property added to the tax roll this year.

Gentlemen:

Although all indicators were for a 15% reduction in appraised values for 2012 during the budget workshop, the certified values presented to us on July 25<sup>th</sup> were just under a 7% reduction. By making some minor modifications after the certified values were received, we are able to keep the tax rate under the effective rate again this year. However, with the requests that were considered and agreed upon from the different departments, primarily in law enforcement, a slight tax increase is necessary to achieve the revenues needed.

Another factor that allowed us to keep costs down is the group health insurance plan's premium rate only increased about 6/10 of a per cent. Included in this budget is a 3% increase in wages and salaries for county employees.

I believe the goal of the Panola County Commissioners' Court is to be a good steward of Panola County taxpayers' funds and I believe we all want to be fiscally conservative. Using these guiding principles, I believe this budget reflects that desire and I urge its adoption without change.

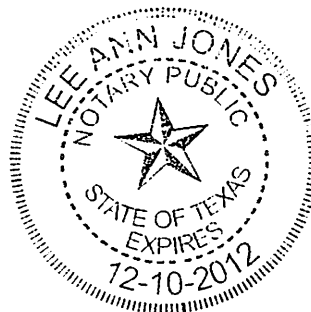
